On December 22, 2006, Rank Group Holdings Limited («**Rank**») published its offer prospectus (the «**Offer Prospectus**») of the public tender offer (the «**Offer**») for all publicly held registered shares of SIG Holding Ltd. («**SIG**»). Pursuant to the Offer Prospectus, the offer period of the Offer was expected to start on January 11, 2007. On December 29, 2006, the Takeover Board (the «**TOB**») issued its recommendation VIII regarding SIG and ordered, among other things, the extension of the cooling-off periods of the Offer and the competing offer until January 26, 2007. Rank published the extension of the cooling-off period on January 5, 2007.

In its recommendation IX regarding SIG, dated January 22, 2007, the TOB ordered, among other things, a further extension of the cooling-off period until February 1, 2007. Rank published the extension of the cooling-off period on January 25, 2007.

On January 29, 2007, the TOB issued its recommendation XI (the «**Recommendation XI**») regarding the Offer Prospectus. In its recommendation the TOB held, among other things, that the Offer Prospectus is compliant with the Swiss Stock Exchange Act, provided, that (i) the Offer Prospectus will be amended in accordance with Recommendation XI, and (ii) the amendments of the Offer Prospectus will be published at the latest on February 2, 2007 in the same form as the Offer has been published (the «**Amendment**»). On February 2, 2007, Rank published the Amendment. In the Amendment it was stated, among other things, that the offer period will start on February 2, 2007 and end on March 1, 2007.

On February 16, 2007, the TOB issued its recommendations XII and XIII regarding SIG (the «**Recommendation XII**») and the «**Recommendation XIII**»). In Recommendation XII, the TOB accepted, among other things, the extension of the offer period of the competing offer until March 29, 2007. At the same time, the TOB ordered in Recommendation XIII that as a consequence of the extension of the offer period of the competing offer the offer period of the Offer shall also be extended until March 29, 2007.
